

LEGAL BASES FOR PARTICIPATION IN THE PROMOTION

1.- ORGANIZING ACCOUNT

Kallia Xa Jewelry, with address @kalliaxa_jewelry organizes the draw for promotional purposes (hereinafter, "the Promotion") at an international level, to be developed through the Internet, exclusively for users of legal age in accordance with the provisions of section conditions to participate.

2.-START DATE AND END DATE

The Promotion will start on Sunday 5/2/2023 and end on Saturday 11/2/2023.

3.- PARTICIPATION REQUIREMENTS AND PROMOTION MECHANICS

The participation requirements will be the following:

- People over 18 years of age may participate.
- Only those Participants who are holders of an Instagram account may participate.
- Participants follow the organizer's account, like and comment on the publication on Instagram, tagging 2 friends, save the post and share it to their stories, during the participation period.
- Participants may only participate with a single profile. If it is detected that a Participant participates with several profiles, they will be disqualified.
